2. The Town Board agrees to cooperate with Larry Slicer and/or Brenda J. Ryan such that they might become eligible for a non-cash charitable contribution to the Town in the maximum amount of \$10,000 associated with the donation of the subject property to the Town of Orleans.

3. Town officials, employees, and attorneys shall execute such documents as are necessary to effectuate the terms herein.

4. This Resolution shall take effect immediately.
