6. Reynolds Notice of Claim update- Supervisor sent a letter to Mr. Reynolds letting him know of sump pump violation of the town sewer ordinance. Mr. Reynolds replied back to Supervisor Rarick stating he will remove sump pump from the town's sewer.

7. Jim Burrows spoke regarding the adjusted IMA with the village of Alexandria Bay and town of Alexandria Bay, Tow of Clayton, he is still waiting on Town of Alexandria to sign.

8. \$90,000 check for Robinson Road – OYA is paying the Town of Orleans for damage to Robinson Road. A motion was made by Peter Wilson and seconded by Mary Ford-Waterman to earmark the \$90,000 for future road repair to Robinson Road.
