WHEREAS, the Town of Orleans has undertaken steps to make improvements to the Waste Water Treatment and Collection Systems Upgrades Addendum.

WHEREAS, the construction and improvements of the infrastructure to service the District, the funding of such construction and all other actions of the Village in connection therewith are subject to compliance with the provisions of the State Environmentally Quality Review Act and the regulations promulgated thereunder at 6 NYCRR, Part 616 ('SEQR"), and

WHEREAS, at a regular meeting of this Board held on <u>January 9, 2014</u>. Part 1 of a long form Environmental Assessment Form ("EAF") in connection with the Action was duly accepted for filing by this Board as prepared by the Town Engineer, a motion was duly passed by which this Board declared itself lead agency, and directing the Town Attorney or Engineer to circulate Part 1 of the EAF to involved agencies identified in Part 1 of the EAF and attached to this Resolution, and

WHEREAS, by the letter dates $\underline{\text{January 10}}$, $\underline{\text{2014}}$, the Town Engineer forwarded a copy of Part 1 of the EAF to the involved agencies as identified by this Board, and

WHEREAS, this Board has received the consent of each of the others identified involved agencies that this Board act as the lead agency for this project, has received comments from the involved agencies, and has thoroughly reviewed those comments in connection with its obligation under SEQR, and

WHEREAS, pursuant to 6 NYCRR Part 617, regular meeting of this Board held on <u>April 4, 2014</u> this Board reviewed Part II and III of the EAF and determined that the project will NOT have a significant effect on the environment, and

WHEREAS, pursuant to Article VIII of the Environmental Conservation Law and the regulations adopted pursuant thereto by the Department of the Environmental Conservation, to wit: 6 NYCRR Part 617, this Board determined that the action will not have a significant effect on the environment, and will not cause any significant impact in the environment, and therefore, the preparation of an environmental impact statement is not required, and

WHEREAS, an Addendum to the project was adopted in January of 2017, changing the location of the proposed solar array, and

WHEREAS, a Letter of Intent to declare no environmental impact regarding the addendum was sent to the involved agencies as identified in Part 1 of the EAF for comment on <u>February 7, 2017</u>, and

NOW, THEREFORE, be it resolved by the Town Board of the Town of Orleans as follows:

- Based upon the examination of the EAF and the criteria set forth in 6 NYCRR Part 617, the Board makes the following findings.
 - A. The proposed action constitutes a Type 1 pursuant to 6 NYCRR Part 617 and this Board has previously determined that a coordinated review is appropriate.
 - B. This Board has received the concurrence from the other involved agencies as identified on Part 1 of the EAF that this Board act as lead agency for this project, and this Board has received and considered the comments, if any, submitted by other involved agencies.
 - C. No potentially significant adverse impacts on the environment are noted on the EAF, None are identified by any of the involved agencies, and none are known by this Board.
 - D. There will be no substantial adverse change in existing air or water quality.
 - E. There will be no hazard created to human health.
 - F. There will be no substantial change in the use or the intensity of the use on the land.
 - G. There will not be a conflict with the community's current plans and goals as officially adopted.
 - H. None of the criteria listed in 6 NYCRR Section 617.11 will be present in the proposed project and no similar criteria which will adversely impact the environment.
