WHEREAS, the Town of Orleans is obligated pursuant to that Consent Order to construct a Solar Array as a public benefit project (the "Project"); and

WHEREAS, St. Lawrence Engineering D.P.C., 17493 Blind Bay Road, Clayton, New York 13624; provides engineering services to the Town of Orleans and is the design engineer for the project and has designed the Solar Array and prepared bidding documents for related major materials; and

WHEREAS, Fourth Coast Inc., 661 Riverside Drive, Clayton, NY 13624 is a domestic corporation and whose shareholders and/or officers are also members of St. Lawrence Engineering D.P.C. and is a certified solar installer, having applied for NYSERDA funding on behalf of the Town for the Solar Array; and

WHEREAS, the Town of Orleans intends to construct the Solar Array with the use of the Town of Orleans employees, as was done with previous Solar Arrays in the Town of Orleans under the direction and supervision of Fourth Coast, Inc.; and

WHEREAS, the Town intends to publicly advertise and solicit bids for major materials associated with the Solar Array such as, but not necessarily limited to: solar modules; inverters, racking and related materials to be purchased in accordance with the procurement policy for the Town of Orleans; and

• WHEREAS, Fourth Coast, Inc. desires to submit a bid for the major materials due to its familiarity with suppliers in the industry; and
